

## NOTICE

### Employment Notice No. 03/2016

- The result indicating scaled score of PnP test and Experience weightage marks of the candidates who had been shortlisted and who appeared for document verification for appointment to the posts of Assistant Operator/ Switch Board Operator Gr. II/ Junior Line Man/ Fitter Gr. II has already been published on the Nigam's website on 02.02.2018.
- Select lists for the posts of Assistant Operator/ Switch Board Operator Gr. II/ Junior Line Man/ Fitter Gr. II purely on the basis of merit rank, preference preferred by the candidates, availability based on category and no. of posts advertised, reservation provisions etc. will be published shortly.
- Selected candidates shall only be intimated on their registered mail ID's and mobile thru email & SMS, date and venue of distribution of the offer letters, reporting & joining thereafter.
- In case selected candidates fail to report & join on the scheduled dates mentioned in their offer letters, no extension in date of joining shall be considered and their offer letters shall stand finally withdrawn thereafter.
- It is hereby informed that selected candidates will be required to submit documents, certificates papers in original along with a set of attested photo copy as listed here under, on the date of reporting & joining:-
  - a) Certificates and mark sheets of Academics in the prescribed qualification for the post.
  - b) Marks sheet as well as Matriculation certificate showing the date of birth.
  - c) Offer letter of appointment of all previous employers and experience certificate with details of assignments undertaken and areas of functions discharged specifying period of services rendered along with Annexure-I of the application detailing period of service with wages.
  - d) Domicile/ Residential certificate issued for employment purposes from SDO/DC of his/her home district in Jharkhand for claiming benefit of reservation.
  - e) i) For SC/ST candidates, caste certificate issued by the SDO/DC of his/her home district. For Primitive Tribe Group certificate issued by SDO/DC of his/her home district.  
ii) For BC-I/BC-II categories, caste and non-creamy layer certificate granted by the SDO/DC of his/her home district issued beyond (1.01.2016) the cutoff date of the employment notification.
  - f) Certificate of permanent physical disability issued by the competent authority in prescribed format, if reservation in PH category is claimed.
  - g) Sports Certificate as prescribed requirement in accordance with GoJ Notification circulated vide Memo No 1709 dtd 12.09.2007 in support of claim for sports quota.
  - h) **Medical fitness certificate granted by Civil Surgeon based on :- (i) Routine Examination of full body, (ii) complete Haemogram including HIV & Hb1Ac, (iii) X-ray chest with P.A. view & (iv) Routine vision examination & Colour blindness test along with a copy of the test reports.**
  - i) Affidavit sworn before a 1<sup>st</sup> Class Magistrate/ Executive Magistrate to the effect that-
    - i) He/she has not accepted/given any dowry (if married) or he/she will not accept give any dowry (If unmarried).
    - ii) He/she is having only one wife/husband in case he/she is married.
    - iii) He/she is presently not working in any Government organization, or if he/she is presently working in any Government organization, he has obtained unconditional NOC from it and no departmental/ criminal proceeding/ enquiry is pending against him/her.
    - iv) That all particulars of information and related documents submitted since the application process are true and genuine and in event of any thing found adverse, concealment,

**misinformation, forged document he/she shall be liable for prosecution and immediate termination from services.**

- j) Certificate of good moral character from the District Magistrate or a Sub-divisional Magistrate of his/her District or Sub-division in which the candidate normally resides.
- k) Candidate who is already employed in a Govt. Organization or PSU should bring unconditional "No objection certificate" / "acceptance of resignation" to join the present assignment from his/her present employer.
- l) Executed service agreement bond with sureties & witnesses before a **1<sup>st</sup> Class Magistrate/ Executive Magistrate**, in the Nigam's prescribed format, of Rs. 1,00,000/-(one lacs) only for serving at least 03 (Three) years in **JUVNL** or allied subsidiary companies.
